Budget Presentation:

Commissioner Meyer presented the 2016-2017 Budget and Appropriation Ordinance #16-01 for Road purposes of Washington Township. Meyer said the budget was basically the same as last year's budget however, the mild winter saved the district money which Meyer is utilizing to appropriate more funds for road repairs. Additionally, he is planning to tar & chipping approximately 5 to 6 miles of township roads this year. Meyer also explained that it was time to replace the district's 1988 Mack truck and he appropriated \$90,000 to replace the truck but that total would not be enough for a new truck. Meyer said he would need to find other ways to finance the vehicle. There was no other discussion.

Public Commentary:

Supervisor Stanula called for Public Commentary and there was none.

Approval of Road & Bridge Budget Ordinance #16-01

Supervisor Stanula asked if there were any questions or discussion on the proposed budget, being none, Stanula for a motion to approve the budget ordinance.


Being no other items of business, Supervisor Stanula asked for a motion to close the Public Hearing.

MOTION:



Public Commentary:


Supervisor Stanula called for public commentary and there was none. Being no public commentary or discussion, Supervisor Stanula asked for a motion to close the Public Hearing.
