Official Proceedings of the Washington Township Board of Trustees December 2, 2019 Washington Township Center 30200 Town Center Road, Beecher, IL

Supervisor Mike Stanula called the meeting to order at **7:00 p.m.** to pay bills for the month of **November** and transact any other business that may come before the Board of Trustees. The meeting agenda and guest sign-in sheet are attached. Supervisor Stanula led the Pledge of Allegiance.

Roll call:

Approval of the Board of Trustees Meeting Minutes Dated November 4, 2019:

Supervisor Stanula asked if there were any corrections or additions to the November 4, 2019 Board meeting minutes as presented. Being none, Stanula asked for a motion to approve the minutes.

Motion:

Trustee Herlitz made a motion to approve the minutes of the November 4, 2019 Board meeting as presented. Trustee Goldrick seconded the motion. There was no discussion on the motion. Roll call vote: Herlitz – yes, Goldrick – yes, Obradovich – yes, Stanula – yes. **Motion passed 4-0**.

Public Commentary: None

Reports:

- Road Commissioner Highway Commissioner Jerry Meyer read his written report (attached) and there were no questions or comments regarding the report. Supervisor Stanula congratulated Meyer for beginning his 29th year as the Washington Township Highway Commissioner.
- 2. <u>Assessor</u> Assessor Mary Tamez reviewed her written report (attached). Tamez told the Board that there were 12 property tax appeals filed in Washington Township.
- 3. <u>Clerk</u> Clerk Burgess reported that 28 seniors attended the Senior Movie night on November 13. The Senior Holiday Dinner & Concert will be held on December 10 at 5:30 pm at the Beecher Amvet Hall. Entertainment will be provided by "The Silver Sounds", a local trio from the area. All food has been ordered and Santa has been scheduled to appear at the dinner.

- 4. <u>Supervisor's Report</u> Supervisor Stanula reported that the sidewalk-leveling project at the Washington Township Center has been completed. The final Senior Bus Trip of the year is Friday, December 6 as the seniors travel to Olivet Nazarene University for the "Sounds of the Season" holiday concert. The trip is free and there are only a few seats remaining.
- 5. <u>Trustees Report</u> Trustee Obradovich gave the Board the most recent list of properties that have been identified as area landmarks by the Beecher Preservation Committee. The list indicates sites that have installed plaques; sites that have received but have not yet installed plaques and sites that are waiting to receive plaques.
 - Trustee Goldrick reported that the Food Pantry passed out 34 Thanksgiving "meals" in November, which was a significant increase over previous month's distributions. Goldrick said the pantry would need to be restocked before Christmas.
- 6. <u>Transportation Report</u> The Township's Dial-A-Ride service provided 48 trips within Washington Township in November. No ride information was available from Will Ride in November. A part-time driver candidate has been found and is currently waiting to attend Pace's required bus-driver training program.
- 7. <u>General Assistance Report</u> Supervisor Stanula reported there were no General Assistance disbursements or new applications received in the month of November.
- 8. <u>Community Building</u> Community Board Manager Teresa Peterson told the Board that the painting has been completed and the upstairs floors have been refinished. The Board of Managers is currently exploring options and pricing to add an elevator or lift to the building. The Community Building Manager's "3rd Annual Holiday Bazaar" is scheduled for this Saturday, December 7.

OLD BUSINESS:

1. <u>Consideration and Approval of 2019 Town Levy Ordinance</u> – The Board reviewed the 2019 Town Levy #19-03 as presented. Supervisor Stanula asked for a motion to approve the levy.

MOTION:

Trustee Obradovich made a motion to approve the Washington Township Levy Ordinance #19-03 as presented. Trustee Herlitz seconded the motion. There was no discussion on the motion. Roll Call vote: Obradovich – yes, Herlitz – yes, Goldrick – yes, Stanula – yes. **Motion passed 4-0.**

Consideration and Approval of 2019 Road & Bridge Levy Ordinance – Commissioner Meyer presented the Road District's 2019 Levy Ordinance #19-04 to the Board.

MOTION:

Trustee Goldrick made a motion to approve the Washington Township Road District Levy Ordinance #19-04 as presented. Trustee Herlitz seconded the motion. There was no discussion on the motion. Roll Call vote: Goldrick – yes, Herlitz – yes, Obradovich – yes, Stanula – yes. **Motion passed 4-0.**

NEW BUSINESS:

- 1. <u>Consideration and Approval of Pending Zoning Applications</u> There were no pending applications to discuss.
- 2. Consideration and Approval of Lease Agreement with Senior Services of Will County Township Attorney Tom Knuth has reviewed the proposed lease agreement between the Township and Senior Services of Will County and found no issues with the verbiage. Supervisor Stanula dated the lease agreement effective December 3, 2019 and completed the "square footage leased" to read Senior Services was leasing the Clerk's office as needed and they will pay \$100 per month for the space. Supervisor Stanula asked for comments, being none he asked the Board for a motion.

Trustee Goldrick made a motion to approve the one-year "Lease Agreement" between Washington Township and Senior Services of Will County as presented with the revisions to include the "Clerk's Office" as the space being leased and a "lease effective" date of December 3, 2019.
