- 2. <u>Assessor</u> No report, Assessor Mary Tamez was not in attendance.
- 3. <u>Clerk</u> Clerk Burgess reported that the Township levies were filed with the Will County Clerk's Office and a Senior Pizza and Movie Matinee is scheduled for January 18 at the Washington Township Center.
- 4. <u>Supervisor's Report</u> Supervisor Stanula reported Renee Black from Senior Services of Will County has scheduled a Senior Resource Program to be held at the Washington Township Center on May 15. The event will last all day during regular business hours. Stanula has also asked for a representative of Senior Services to speak at the Township's Senior Breakfast in April.

- 5. <u>Trustees Report</u> –Trustee Goldrick reported over 30 residents utilized the Food Pantry in December.
- 6. <u>Transportation Report</u> The Township's Dial-A-Ride service provided 46 trips within Washington Township in December. No ride information was available from Will Ride in December.
- 7. <u>General Assistance Report</u> Supervisor Stanula reported there was one Emergency Assistance disbursement in the amount of \$161.76 in December. The disbursement was used to pay a resident's utility bill.

1. <u>Consideration and Approval of Pending Zoning Applications</u> – St. John's Lutheran Church, in Eagle Lake has requested a Special Use Permit to install a lighted dynamic supply (LED) sign within 300' of a residential zoning district. The Will County Health Department already responded to their request and had no objections as long as there are no "adverse effects" to the existing water and sewage systems. The Board had no concerns or issues with the request and a Public Hearing is scheduled on February 4 at 6:30 pm at the Will County Office Building.

Motion:

Trustee Goldrick made a motion to recommend the approval of a Special Use Permit (Case #ZC-19-080) to St. John's Lutheran Church to install a "dynamic display". Trustee Heldt seconded the motion. Supervisor Stanula will draft a letter to the Will County Land Use Board stating Washington Township supports and recommends the passage of the Special Use Permit.
