# Official Proceedings of the Washington Township Board of Trustees December 7, 2020 Washington Township Center 30200 Town Center Road, Beecher, IL

Supervisor Mike Stanula called the meeting to order at 7:06 p.m. to pay bills for the month of **November** and transact any other business that may come before the Board of Trustees. The meeting agenda and guest sign-in sheet are attached. Supervisor Stanula led the Pledge of Allegiance.

# Approval of the Board of Trustees Meeting Minutes Dated November 2, 2020:

Supervisor Stanula asked if there were any corrections or additions to the November 2, 2020 Board meeting minutes as presented. Being none, Stanula asked for a motion to approve the minutes.

# Motion:

Trustee Goldrick made a motion to approve the minutes of the November 2, 2020 Board meeting as presented. Trustee Heldt seconded the motion. There was no discussion on the motion and the motion was unanimously approved by voice vote.

# Public Commentary: None

# Reports:

- Road Commissioner Commissioner Smith was unable to attend the meeting but left a
  written report. Supervisor Stanula read his report to the Board and there was no discussion
  regarding his report.
- 2. <u>Assessor</u> Assessor Tamez reviewed her written report (attached). Tamez was concerned about the County's recent update to their website, which included removing all of the township's property data with no assurances the data will be added back anytime soon. This has resulted in multiple phone calls to her office and a work around using the township's PAMs program could cost the township \$3600, plus an annual fee of \$1000. The Board will need more information to determine if the cost supports the benefits.
- 3. <u>Clerk</u> Clerk Burgess reported that only the Republican Party held a Caucus for the upcoming 2021 Consolidated Election. The Republican Chairperson has filed a "Certificate of Nomination by Caucus" document with the Clerk's office.

4. <u>Supervisor's Report</u> – Supervisor Stanula reported that the GO Bond that was received to build the Washington Township Center has been paid in full and he has received a copy of the paid note. Will County has approved the township's CARES Grant application and the township will receive a \$1,888.51 reimbursement to cover the costs of Covid related expenses incurred since March. The township is still eligible for up to \$8,100 in additional expenses as needed. Trustee Heldt questioned how often the building was being cleaned for Covid and it was recommended that more Covid disinfecting solution be purchased to ensure ongoing cleaning can occur without any disruptions.

Will County Green sent the final information regarding the Hazardous Waste & Electronics Recycling event held on November 14 at the Washington Township Center. There were 415 appointments made and a total of 454 vehicles were served. Of these totals, 391 (86%) dropped off electronics and 367 (81%) dropped off some type of hazardous waste.

- 5. <u>Trustees Report</u> No reports.
- 6. <u>Transportation Report</u> The Township's Dial-A-Ride is still suspended at this time. Will Ride reported four trips in August and three trips in September for township residents.
- 7. <u>General Assistance Report</u> There were no General Assistance disbursements during November.

Community Board Building Manager Teresa Peterson told the Board that bids have been received for the sidewalk project and the work will be done in the spring. The Board is also looking into replacing the refrigerator and oven in the kitchen.

## **OLD BUSINESS:**

1. <u>Consideration and Approval of 2020 Town Levy Ordinance (#20-03)</u> - The Board reviewed the 2020 Town Levy #20-03 as presented. Supervisor Stanula asked for a motion to approve the levy.

# **MOTION:**

Trustee Heldt made a motion to approve the Washington Township 2020 Levy Ordinance #20-03 as presented. Trustee Goldrick seconded the motion. There was no discussion on the motion. Roll Call vote: Heldt – yes, Goldrick – yes, Stanula – yes, Obradovich – yes, Herlitz – yes. **Motion passed 5-0.** 

2. <u>Consideration and Approval of 2020 Road District Levy Ordinance (#20-04)</u> — The Board reviewed the Road District's 2020 Levy Ordinance #20-04. It was noted that the Village of Beecher receives a percentage of the Road Levy based on the mileage of roads within the village as determined by the county. This results in the Road District receiving less than the actual total amount of the levy.

### **MOTION:**

Trustee Goldrick made a motion to approve the Washington Township Road District 2020 Levy Ordinance #20-04 as presented. Trustee Heldt seconded the motion. There was no discussion on the motion. Roll Call vote: Goldrick – yes, Heldt – yes, Herlitz – yes, Obradovich – yes, Stanula – yes. **Motion passed 5-0.** 

### **NEW BUSINESS:**

- 1. <u>Consideration and Approval of Pending Zoning Applications</u> There were no new zoning requests or applications to address.
- 2. <u>Consideration and Approval of General Assistance Updated Guidelines</u> Supervisor Stanula reported that it had been several years since there were any changes made to the GA Guidelines. He will be recommending revisions to the "monthly income" limits to be more in line with other townships in the surrounding area and to adjust for inflation. The Board will review the changes at the January meeting.
- 3. <u>A Resolution in Appreciation for Highway Commissioner Jerry K. Meyer</u> Supervisor Stanula read aloud Resolution # 20-02 "A Resolution in Appreciation for Washington Township Highway Commissioner (Jerry K. Meyer) On His Retirement". Stanula asked for a motion to approve the resolution.

Trustee Herlitz seconded the motion. There was no discussion on the motion and the motion was unanimously approved by voice vote.

# **Township Meeting Notes:**

- We have had 186 sales between January 1, 2020 and November 11, 2020. Information is up to date through November 11<sup>th</sup>.
- The new exemption application totals:
  - o 7 Senior Homestead Exemptions
  - o 13 Senior Freeze Exemptions
  - o 22 Certificates of Error
  - 2 Disabled Person Exemption
  - 2 Disabled Veterans Exemptions
  - 39 Home Improvement Exemptions

These numbers are in addition to the 2020 exemption totals that were rolled over for the 2020 year due to Covid. Exemption forms for the 2020 year can be filed throughout next year!

- I am updating PAMS with all of the permits from the fall and making field check sheets for those needing to have additional value added to the assessments. We can no longer make changes for the 2020 year so this will all be new value for 2021.
- I am continuing to update all of the properties from the field checks. These changes
  will be added as of 2021. Those that qualify for the Home Improvement Exemption
  will receive a letter in the mail with the change made.
- The County has updated their website and removed all of our property data. I have had lots of information requests due to the County no longer having this information. When speaking with them, they are unsure if/when this information would be available. I talked with our PAMS program to see if there was a way we could link this information to our website and it would cost \$3,600 dollars and an annual licensing fee of \$1,000 I feel it is quite expensive to have for the 10ish inquiries we have weekly.
