Official Proceedings of the Washington Township Board of Trustees June 7, 2021

Washington Township Center 30200 Town Center Road, Beecher, IL

Supervisor Mike Stanula called the meeting to order at 7:22 p.m. to pay bills for the month of <u>May</u> and transact any other business that may come before the Board of Trustees. The meeting agenda and guest sign-in sheet are attached. Supervisor Stanula led the Pledge of Allegiance.

Roll call:

Approval of the Board of Trustees Meeting Minutes Dated May 3, 2021:

Supervisor Stanula asked if there were any corrections or additions to the May 3, 2021, Board meeting minutes as presented. Being none, Stanula asked for a motion to approve the minutes.

Motion:

Trustee Herlitz made a motion to approve the minutes of the May 3, 2021, Board meeting as presented. Trustee Heldt seconded the motion. There was no discussion on the motion and the motion was unanimously approved by voice vote.

Public Commentary: None

Reports:

- Road Commissioner Commissioner Smith reviewed his written report (attached). Smith said a
 large culvert on Stoney Island was inspected by an engineer and was determined to be in good
 condition and will not need to be replaced.
- 2. <u>Assessor</u> Assessor Tamez reviewed her written report (attached). Her office has received 42 applications for various tax exemptions, which included 16 "Certificate of Errors" that typically involve farms that no longer have "out" buildings on the property.
- 3. <u>Clerk</u> No report.
- 4. <u>Supervisor's Report</u> Supervisor Stanula reported that the Glass & Paper Recycling Center located at the Washington Township Center has officially closed. As expected, there have been several calls regarding why the recycling center was closed. The "used" book bin is the only recycle container remaining at the township center and Stanula is considering relocating the bin to another location or remove it permanently.
- 5. <u>Trustees Report</u> No reports.
- 6. <u>Transportation Report</u> The Township's Dial-A-Ride was reopened on June 1st. There have been a few calls, but there have been no riders to date. Will Ride reported 12 trips in February for township residents.

7. <u>General Assistance Report</u> – Supervisor Stanula reported there were two Emergency Assistance disbursements in May totaling \$1,749.65. The funds were used to pay two utility bills for a qualifying resident.

<u>Community Building</u> – Community Board Manager Teresa Peterson reported the east and west sidewalks have been replaced. The front sidewalks and ramp to the front door should be completed in the coming week.

OLD BUSINESS:

1. <u>Consideration and Approval of 2021-2022 Town Budget</u> – The Board reviewed the proposed budget and no changes were recommended.

MOTION:

Trustee Heldt made a motion to approve Town Account Budget and Appropriation Ordinance #21-01 as presented. Trustee Herlitz seconded the motion. There was no discussion on the motion.

Roll call vote: Heldt - yes, Herlitz - yes, Obradovich - yes, Peterson - yes, Stanula - yes.

Motion passed 5-0.

2. <u>Will County Green Recycling Discussion / Presentation</u> – No discussion, this item will be removed from future agendas.

NEW BUSINESS:

1. <u>Consideration and Approval of Pending Zoning Applications</u> – There were no new zoning requests or applications to address.

Supervisor Stanula has a sent letter to the county regarding the zoning issues around the "Party Ranch" on W. Corning Road, which was brought to the Board's attention by Troy Ronk at the May meeting. The letter outlined the improper use of the property per zoning requirements and many other zoning violations.

- 2. <u>Consideration and Approval of Beecher 4th of July Sponsorship Request</u> The Township has been an annual sponsor of this event and due to Covid, this year's celebration has been pushed back to the Labor Day weekend. The Board would like more details surrounding the celebration and is prepared to support the event, preferably by sponsoring a band or other specific type of attraction. Supervisor Stanula will reach out the 4th of July Commission for more details.
- 3. <u>Annual Sikich Audit</u> The Township's annual financial audit is due and Stanula has signed the necessary paperwork to start the audit process.
- 4. <u>"Aggregation Program Agreement" between Washington Township and Nania Energy Advisors</u>
 The Township's aggregation agreement with Nania Energy Advisors (broker) is up for renewal. According to Nania, their program will save participating residents up to 13% on their electric bill, as compared to going strictly with ComEd. The program is still an "Opt-out" program and all affected residents have the option to choose if they would like to utilize Nania as their electrical supplier. The Board instructed Supervisor Stanula to renew the aggregation agreement.

PAYMENT OF BILLS:

General Assistance Fund

There were two Emergency Assistance disbursements in May totaling \$1,749.65.

MOTION:

Trustee Heldt made a motion to approve General Assistance bills in the amount of <u>\$1,749.65</u>. Trustee Peterson seconded the motion. There was no discussion on the motion and the motion was unanimously approved by voice vote.

Town Account (including Transportation Fund)

The board reviewed the bills as reviewed by the Supervisor and presented by the Clerk. The carpet was cleaned at the Washington Township Center and the cost included treating some areas for possible mold due to water leaks around a few windows.

MOTION:

Trustee Herlitz made a motion to approve payment of all applicable payroll, bills, debits and appropriate transfers from the Town Account totaling \$12,566.49. Trustee Heldt seconded the motion. There was no discussion on the motion and the motion was unanimously approved by voice vote.

Road & Bridge Bills

The board reviewed the Road District's bills as prepared by Commissioner Mike Smith and presented by the Clerk.

MOTION:

Trustee Heldt made a motion to authorize payment of all applicable payroll, bills, and appropriate transfers or debits from the Road & Bridge Account totaling \$25,126.08. Trustee Herlitz seconded the motion. There was no discussion on the motion and the motion was unanimously approved by voice vote.

- I went out measuring with Tiffany this last week. We completed some of the field work. I will likely be going out with her again in the next few weeks. We are about half way caught up.
- We have started to get calls and receive applications for the Senior Exemption
 for those that turn 65 this year. These forms are also on the Will County

 of applications are:

 - Certificate of Error 16
 - Home Improvement Exemption 15
 - Senior Freeze 3
 - Senior Homestead Exemption 5
- All of our changes need to be completed by mid-June. I am almost finished with all of the changes with mapping and all of the field work. That is what has generated all of the home improvement exemptions.
- We have been given a spread sheet the County ran with 73 parcels that have property classification changes that need to be updated. It was a report run to
