## Official Proceedings of the Washington Township Board of Trustees August 2, 2021

#### Washington Township Center 30200 Town Center Road, Beecher, IL

Supervisor Mike Stanula called the meeting to order at 7:00 p.m. to pay bills for the month of <u>July</u> and transact any other business that may come before the Board of Trustees. The meeting agenda and guest sign-in sheet are attached. Supervisor Stanula led the Pledge of Allegiance.

#### Roll call:

#### Approval of the Board of Trustees Meeting Minutes Dated July 8, 2021:

Supervisor Stanula asked if there were any corrections or additions to the July 8, 2021, Board meeting minutes as presented. Being none, Stanula asked for a motion to approve the minutes.

#### Motion:

Trustee Herlitz made a motion to approve the minutes of the July 8, 2021, Board meeting as presented. Trustee Heldt seconded the motion. There was no discussion on the motion and the motion was unanimously approved by voice vote.

#### **Public Commentary:**

None

#### Reports:

- 1. <u>Road Commissioner</u> Commissioner Smith was not in attendance but left a written report for the Board. Supervisor Stanula read his report and there was no discussion regarding the information.
- 2. <u>Assessor</u> Assessor Tamez reviewed her written report (attached). There were no questions or comments regarding her report.
- 3. <u>Clerk</u> No report.
- 4. <u>Supervisor's Report</u> Supervisor Stanula sent the Will County Zoning Board a letter requesting they deny the Special Use Permit requested by Matt Krudup to hold a "music festival with overnight camping". The letter outlined the reasons why the Board is requesting that the Special Use Permit be denied.

Stanula received an email from residents Bill & Robin Giese, who live in Eagle Lake, explaining a house was recently purchased at 28808 S Yates Avenue and is being advertised for "Summer Party Time" rentals. There have been parties on several weekends and neighbors have reported hearing gun fire, loud music, and crowds in the area until 2 am in the morning. Someone was recently burning garbage on the property and the Will County Sheriff's Office was contacted.

There has been a recent surge of these types of parties and other questionable activities in the township and Stanula has contacted Will County Board member Judy Ogalla, who has promised to bring up these concerns to the Will County Zoning Board, in hopes that action can be taken to restrict or set reasonable guidelines for these events.

- 5. <u>Trustees Report</u> No reports.
- 6. <u>Transportation Report</u> There were no riders on the Township's Dial-A-Ride service in July. Will Ride did not send a ridership report in July.
- 7. <u>General Assistance Report</u> There were no new applications or disbursements from the General Assistance fund in July.

#### **OLD BUSINESS:**

1. <u>Solar Farm Discussion</u> – Trustee Heldt has made several phone calls trying to find out who is responsible for the upkeep of the solar farm at Corning and Dixie Highway, which was one of the first solar farms built in Will County. Heldt learned that the operations and maintenance of the solar farm was subcontracted to Cypress Creek Renewables. She contacted Cypress Creek and was told that cameras are now installed on the property, and they would be willing to discuss their process for vegetation management, which was never completed.

Heldt indicated that current county regulations are not being followed and township residents should not have to monitor these areas for the county, and it was her opinion, that there is no reason to approve additional solar farms in Washington Township until the county enforces their own guidelines. Trustee Obradovich suggested the county be contacted regarding an explanation as to how solar farm rules are being enforced. Supervisor Stanula said Will County board member Judy Ogalla and Zoning Board representative Bobbie Peterson are aware of the issues in the township and will be bringing these items up at the Will County Zoning Board meeting on August 3<sup>rd</sup>.

#### **NEW BUSINESS:**

- 1. <u>Consideration and Approval of Pending Zoning Applications</u> The Township has received a Special Use Permit request from Borrego Solar Systems to construct a 20-acre solar farm at Cottage Grove Ave and Indiana Ave. Due to the recent issues with the current solar farm not following Will County requirements and because of the lack of enforcement to follow these guidelines, the Board is not prepared to approve any additional solar farms in Washington Township at this time. The Board asked Supervisor Stanula to send a letter to the Will County Zoning Board asking them to deny Borrego's application for a Special Use Permit. The letter will also reference the current issues with the Summit Ridge solar farm as a factor as to why the Board is opposed to the construction of additional solar farms at this time.
- 2. <u>Reopening Senior Programs Discussion</u> Due to the current outbreak of the Covid-19 Delta variant, all senior programs are still suspended indefinitely.

- 3. <u>Property Ordinance Discussion</u> The Board is looking at the possibility of creating an ordinance to limit certain activities, such as direct code violations and "for profit" parties, and to ensure county ordinances are followed and enforced. It was recommended that Attorney Tom Knuth be contacted to discuss the process and legality to pass such an ordinance and enforcement options. The ordinance would help to ensure zoning codes are being followed and to protect residents from illegal and unauthorized activities.
- 4. <u>Beecher EMA Sponsorship Request</u> Supervisor Stanula received a request from the Beecher EMS to assist in sponsoring the program. The Board was not in favor of just giving a cash sponsorship and would prefer that the funds be used to pay for equipment or training. Supervisor Stanula will contact members of the EMA to determine if the Township can sponsor training or purchase equipment.
- 5. <u>Beecher Lion's Club Sponsorship Request</u> The Lion's Club is providing a Beef Dinner at the 4<sup>th</sup> of July Commission's September festival and looking for sponsors. The Board discussed the sponsorship and would prefer to sponsor an event versus just having Washington Township written on a sign. The Board would consider sponsoring the Lion's Club Halloween Hot Dog Roast during Trick or Treat hours. Lion's member George Schuitema will speak to the Lion's Club about the township's request.
- 6. Consideration to Upgrade the Interior Lighting at the Washington Township Center —
  Supervisor Stanula recommended that the old fluorescent lighting at the Washington
  Township Center be upgraded to more energy efficient LED lighting. There are programs
  that are available to help defray the cost of the upgrades and there would be a considerable
  energy savings. The Board was interested in the project and Stanula will research what
  options are available and report back at the September meeting.

#### PAYMENT OF BILLS:

#### Town Account (including Transportation Fund)

The board reviewed the bills as reviewed by the Supervisor and presented by the Clerk.

#### **MOTION:**

Trustee Herlitz made a motion to approve payment of all applicable payroll, bills, debits, and appropriate transfers from the Town Account totaling \$11,230.85. Trustee Peterson seconded the motion. There was no discussion on the motion and the motion was unanimously approved by voice vote.

#### Road & Bridge Bills

The board reviewed the Road District's bills as prepared by Commissioner Mike Smith and presented by the Clerk.

#### MOTION:

Trustee Heldt made a motion to authorize payment of all applicable payroll, bills, and appropriate transfers or debits from the Road & Bridge Account totaling \$46,505.11. Trustee Obradovich seconded the motion. There was no discussion on the motion and the motion was unanimously approved by voice vote.
