Official Proceedings of the Washington Township Board of Trustees November 1, 2021 Washington Township Center 30200 Town Center Road, Beecher, IL

Supervisor Mike Stanula called the meeting to order at 7:02 p.m. to pay bills for the month of <u>October</u> and transact any other business that may come before the Board of Trustees. The meeting agenda and guest sign-in sheet are attached. Stanula led the Pledge of Allegiance.

Roll call:

Approval of the Board of Trustees Meeting Minutes Dated October 4, 2021:

Supervisor Stanula asked if there were any corrections or additions to the October 4, 2021, Board meeting minutes as presented. Being none, Stanula asked for a motion to approve the minutes.

Motion:

Trustee Herlitz made a motion to approve the minutes of the October 4, 2021, Board meeting as presented. Trustee Obradovich seconded the motion. There was no discussion on the motion and the motion was unanimously approved by voice vote.

Public Commentary: None

Reports:

- Road Commissioner Commissioner Smith was not in attendance but left a written report
 (attached) for the Board. Supervisor Stanula read the report and there were no comments or
 discussion regarding the report.
- 2. <u>Assessor</u> Assessor Tamez reviewed her written report (attached). There were no comments or questions regarding her report.
- 3. <u>Clerk</u> No report.
- 4. <u>Supervisor's Report</u> Supervisor Stanula recently attended a Will County Public Hearing regarding the County Board's proposal to reduce the number of districts in Will County from 13 to 11. The proposal moves Washington Township into a much larger district that expands through Peotone, Manhattan and north to New Lenox. The restructuring was explained as an attempt to "even" the population throughout the proposed 11 districts.

Stanula said the majority of those in attendance at the hearing were farmers, who were against the redistricting proposal and spoke out that the agricultural community is losing

representation by being combined with cities and villages. Stanula also spoke on behalf of Washington Township explaining that the rural areas, such as our township, will no longer have equal representation with the proposed boundary changes. The County Board members did not comment on any of the public concerns; however, the Board met the following day and according to sources, was going to revisit the proposal. No additional information is currently available.

The Will County Planning Board recently approved the permits to build two new solar farms in Washington Township, even after the township sent a letter asking for the permits to be denied. Bobbie Peterson was the only Board member to no vote on the request. Currently, the only solar farms in Will County are in Crete and Washington Townships and the Will County Board has consistently approved their permit requests.

Trustee Heldt said the solar farm in Washington Township on Corning Road has begun to add additional landscape buffers as per the County's guidelines. The solar farm is still not operational.

- 5. <u>Trustees Report</u> No reports.
- 6. <u>Transportation Report</u> There were no riders on the Township's Dial-A-Ride service in October. Will Ride did not submit an invoice in October.
- 7. <u>General Assistance Report</u> Supervisor Stanula reported there was one family that needed Emergency Assistance in October. Four checks were written totaling \$1838.20 to cover miscellaneous past due expenses.

<u>Community Building</u> – Trustee Peterson, who is on the Community Building's Board of Managers explained there are local organizations utilizing the Community Building without notifying the Board of Managers. In some cases, the building is not being cleaned and the Board has to arrange for cleaning. A letter is being prepared to send to local organizations to ask them to contact the custodian or Board when they will be using the building.

OLD BUSINESS:

- 1. <u>Consideration to Upgrade the Interior Lighting at the Washington Township Center</u> Supervisor Stanula reported he had a recent discussion with the vendor regarding the lighting project and was told the waiting list for this project would be several months. Stanula indicated the project is not critical to the township at this time and he will contact the vendor in 2022.
- 2. <u>Consideration and Approval of 2021 Town Levy Ordinance</u> Clerk Burgess explained the Levy was unchanged from last year and if there were no corrections or changes, the levy could be approved anytime between now and the end of December. Trustee Obradovich reviewed the support documentation and discussed the new construction and overall EAV numbers utilized for the worksheet. There were no additional comments regarding the proposed levy.

MOTION:

Trustee Heldt made a motion to approve the Washington Township 2021 Levy Ordinance #21-03 as presented. Trustee Peterson seconded the motion. There was no discussion on the motion. Roll Call vote: Heldt – yes, Peterson – yes, Stanula – yes, Obradovich – yes, Herlitz – yes. **Motion passed 5-0.**

3. <u>Consideration and Approval of 2021 Road & Bridge Levy Ordinance</u> - The Board reviewed the Road District's 2021 Levy Ordinance #21-04. Clerk Burgess explained that Commissioner Smith has reviewed the levy and recommends passage of the ordinance.

MOTION:

Trustee Heldt made a motion to approve the Washington Township Road District 2021 Levy Ordinance #21-04 as presented. Trustee Peterson seconded the motion. There was no discussion on the motion. Roll Call vote: Heldt – yes, Peterson – yes, Herlitz – yes, Obradovich – yes, Stanula – yes. **Motion passed 5-0.**

NEW BUSINESS:

- 1. <u>Consideration and Approval of Pending Zoning Applications</u> There were no new zoning requests or applications to address.
- 2. <u>Website Upgrade</u> Chris Russell, who owns Russell Publications, has created a new website company, and has reached out to Clerk Burgess about upgrading the Township's website. Burgess has had some email communication with Russell but has not setup a time to meet with him. Burgess suggested upgrading the site a few years ago, however a quote from Webfoot Designs, our current provider, could not be justified at that time. Webfoot currently maintains the township's website and email on their servers and any discussion with Russell must also include email as well as website upgrades. Burgess will contact Russell and get back to the Board with his findings.
- 3. Newsletter Update Historically, the Village of Beecher and Washington Township have mailed their biannual newsletters during the same month. The village solicits advertisements for both newsletters and then splits the revenue with the township, which gives advertisers exposure across the entire township. Due to the ongoing Covid pandemic, the township did not publish a fall newsletter in 2021, which was the first time the village and township were not publishing newsletters at the same time. This action prompted the village Board to decide that they will no longer partner with the township on newsletters advertisements. The township Board would like more information about the village Board's decision and Supervisor Stanula will reach out to Mayor Meyer to discuss what the concerns are and possibly reinstate that partnership.

PAYMENT OF BILLS:

Town Account (including Transportation Fund)

The board reviewed the bills as reviewed by the Supervisor and presented by the Clerk.

MOTION:

Trustee Obradovich made a motion to approve payment of all applicable payroll, bills, debits, and appropriate transfers from the Town Account totaling <u>\$12,605.42</u>. Trustee Heldt seconded the motion. There was no discussion on the motion and the motion was unanimously approved by voice vote.

Road & Bridge Bills

The board reviewed the Road District's bills as prepared by Commissioner Mike Smith and presented by the Clerk.

MOTION:

Trustee Herlitz made a motion to authorize payment of all applicable payroll, bills, and appropriate transfers or debits from the Road & Bridge Account totaling <u>\$56,925.08</u>. Trustee Peterson seconded the motion. There was no discussion on the motion and the motion was unanimously approved by voice vote.

General Assistance Bills

As per Supervisor Stanula's General Assistance report, a total of \$1,838.20 was spent for an Emergency Assistance case.

MOTION:

Trustee Peterson made a motion to authorize payment of <u>\$1.838.20</u> from the General Assistance Account. Trustee Heldt seconded the motion. There was no discussion on the motion and the motion was unanimously approved by voice vote.
