To approve a proposed 2022 property tax increase of 5.71% (Tax Levy Ordinance #22-04) for Road purposes of Washington Township.

Call to order at 6:45 pm by Supervisor Stanula.

MOTION to Open Hearing:

Trustee Peterson made a motion to open the Public Hearing. Trustee Herlitz seconded the motion. There was no discussion on the motion and the motion was unanimously approved by voice vote.

Presentation of Tax Levy Ordinance #22-04:

Commissioner Mike Smith presented proposed Tax Levy Ordinance #22-04 for Road purposes of Washington Township. The 2022 levy represents a 5.71% increase over the 2021 levy and the total amount to be levied is \$702,813, which is divided into two funds. The General Road Fund will receive \$649,188 and the County Aid Bridge Fund will receive the balance of \$53,625. The Village of Beecher receives a portion of the levy, which is determined by the county and is taken directly from the General Road Fund.



ORDINANCE NO. # 2022-04

An ordinance levying taxes for all road purposes for WASHINGTON TOWNSHIP Road District
WILL County, Illinois, for the tax year 2022, collectable in 2023.

BE IT ORDAINED by the Board of Trustees of WASHINGTON Township, WILL County, Illinois,
as follows:

SECTION 1: That the Highway Commissioner of the WASHINGTON TOWNSHIP Road District
on **December 5, 2022 does hereby determine and declare that the sum of -- (\$959,139.00) --**
Nine-hundred fifty-nine thousand one-hundred thirty-nine & no/100 Dollars are hereby levied
upon all property subject to taxation within the Road District as that property is assessed and equalized,
in order to meet and defray all the necessary expenses and liabilities of the Road District as required by
statute or voted by the people in accordance with the law, for such purposes as:



SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary


to be raised by taxation for road purposes for WASHINGTON TOWNSHIP ROAD DISTRICT.


